# Notes from Green Bay Area Branch History 1927-1981 and the 70th Anniversary History Update 1982-1997:

These notes from our Branch History will be included on our Bay Notes to update our members about the Branch as we approach our 90th Anniversary. If anyone would like to help update our branch history from 1997- present please contact Dotty Juengst.

From History 1927-1981, compiled by Margaret Krings, Historian:

"On January 31, 1927, a small group of college women met at the YMCA with the purpose of forming a branch of the American Association of University Women. They elected the following officers: President, Julia Conley: First Vice-President, Henrietta Gallagher; Second Vice-President, Mrs. Robert Hays; Secretary, Edythe Thomas; Treasurer, Dorothy Day; Chairman of Hospitality, Publicity and Education, Mrs. Carl Young, Florence Walker, and Marian McCullough, respectively. The organization was established as the AAUW-Green Bay Branch. In 1980 the name of the groups was changed to AAUW-Green Bay Area Branch. This group of women was the founding core of over fifty years of work in

fulfillment of the national, state and local purposes of the American Association of University Women. This history is an attempt to chronicle the efforts of these women and successive members to fulfill those purposes.

One of the primary purposes of AAUW is to encourage higher education for women. At the second meeting, February 10, 1927 the branch began its goal toward fulfilling this need. The first scholarship of fifty dollars was given to Vivian Nichols, a graduate of Green Bay West High School. Since that time, the local branch has given over \$30,000 (1927-1981) to international, national and local scholarships funds for study on graduate and undergraduate levels."

# Notes from Executive Board Meeting – November 9, 2015

#### PRESIDENT REPORT:

- 1. <u>By-Laws update</u> National requires us to update By-Laws by April. National has just sent model by-laws. Janice and Dotty will work the Sara on the new by-laws in January.
- 2. <u>Update on regional meeting</u>: Bev, Sue and Sara went to regional meeting in Appleton. We hope to attend more of these meetings, because it was very valuable to share ideas and methods of doing things.
- \* New District Representative needed for District 5. This is a state position and requires 3 meetings for state meetings and to organize one district wide meeting. Anyone interested can feel free to call Sara regarding it.

\*Changes to District 5: It will be voted on at the convention to expand District 5 to include Oshkosh, Sheboygan, West Bend, Rhinelander, Wisconsin Rapids and Wausau. District 5 will have one of the largest memberships in the state. Not sure how it will affect this branch. We will have fewer times to take responsibility for the state convention. Anyone with strong feeling about this should let those representing the branch at convention know.

\*April 22-24, 2016 - <u>State Convention</u> at the Crown Plaza in Madison.

\*How Scholarships are chosen: AAUW
National has been advised by the IRS that it
is concerned with AAUW members
reviewing financial records of scholarship
recipients and as well as the possibility that
candidates with connections may receive
preference. This is going to require us to
rethink our method of selecting scholarship
recipients. We are hoping to receive a
written update on this matter. Various
possibilities were discussed. Sandy
suggested she contact Scholarship, Inc. to
see if it is possible that they could handle
this for us.

\*Vouchers: We need to voucher in-kind donations. We need to do this it is cleaner and fairer and well as realistically know what is needed. Send out a general voucher form to everyone. It will be attached to the newsletter and mentioned at next meeting.

\*Update on AAUW Fundraising Policy 501: National as confirmed what we can and cannot do regarding donations to other

nonprofit organizations. Branches cannot give donations to another charity unless it is in accordance with AAUW's mission. The National Railroad Museum's festival of Trees was discussed. Is this a donation or is this a "space"? As we are beyond the deadline, it was decided not to do it this year.

## DREAMERS AND DOERS VOLUME 2:

It was affirmed that the branch has approved the committee spending up to \$2000 on volume 2. Dotty reported 22 are done and some editing has been done to get them in a similar format. Next year is our 90<sup>th</sup> anniversary for this branch. To begin the celebration, Joanne Rathburn will be willing to do small write-ups on former presidents of this branch. It was decided to upload previous booklets to our website and put excerpts in the BayNotes.
