WHY ARE WOMEN "SERVING TIME" FOR NON-CRIMES?

A presentation by Andrea L. Lewis and Sara L. Sommervold, researchers and authors of the article, *Death, But Is It Murder? The Role of Stereotypes and Cultural Perceptions in the Wrongful Convictions of Women,* published in the <u>Albany Law Review</u>. They will discuss their study and what can be done to prevent miscarriages of justice in the future. This is clearly another area where women need our help. Please come, bring a friend and learn.

<u>Making a Murderer</u>, the Manitowoc murder documentary brought to the public's eye wrongful convictions. It created considerable disagreement regarding Steven Avery's guilt or innocence. But, no one would argue that a person should "serve time" for a crime they didn't commit.

How do you feel about spending "time" for no crime? Their research found that 63% of all exonerated women were convicted of non-crimes, events proven to be accidents or illnesses. A number of factors explain these statistics. Women are likely to be convicted of crimes involving a loved one or family member. For this reason, DNA evidence is rarely a factor. Proving an accident or illness is difficult and usually involves technical and scientific evidence. Stereotypes and cultural perceptions of women as mothers and nurturers also contribute to the wrongful convictions of women. All of these issues make wrongfully convicted women's cases more complicated and expensive to litigate.

It is sad to read how our societal stereotypes of what a perfect mother should be leads to innocent women being convicted of crimes that were accidents or illness. It is sad how we demonize these women in the press. We punish mothers for not keeping their children safe by convicting of murder. For example, a prosecutor found a mother's casual comment to a friend that she was considering modeling the mother's "motive" for murdering her child when it is was actually an accident her mobile home burned. Another mother who was pursuing a degree was obviously not devoted enough to her child so she must have killed her child when it was later proven the child died of an illness. Both these women spent many years in jail. How many women are in jail do not have the resources to prove their innocence?

<u>April Meeting</u>: Note change in time and place than usual. Our April meeting began last August when I read an article describing a study of wrongfully convicted women and found that 63% of all wrongfully convicted women in the U.S. were convicted of crimes that were actually proven (years later) to be accidents or illnesses.

That is the women exonerated. Think of the number of women in jail who do not have the resources to prove their innocence! I made a few calls and Andrea Louise Lewis, one of the authors of the study, was willing to coming to speak! A few weeks ago I mentioned to her that I had read her law review article. She said, "You read my article? I will ask my colleague if she can attend." Her cowriter Sara Sommervold will join her! Their article is a law review article, *Death*, *But Is It Murder?* The Role of Stereotypes and Cultural Perceptions in the Wrongful Convictions of Women published by the Albany Law Review.

If you have never read a law review article, you should know there is a standard (somewhat stilted) style. There are also LOTS of footnotes. Ignore the footnotes and the style and read it. It is horrifying to read how our societal stereotypes of what a perfect mother should be leads to innocent women being convicted of crimes that were accidents or illness. It is sad how we demonize these women in the press, making it difficult for them to find unbiased juries. Read how difficult and expensive it is to prove a non-crime, making it nearly impossible for low-income women to properly defend themselves.

For another read, try Mother Jones article, "Why Is It So Hard for Wrongfully Convicted Women to Get Justice?" Read how prosecutors find a mother's casual comment to a friend that she was considering modeling the mother's "motive" for murdering her child. Another mother who was pursuing a degree was obviously not devoted enough to her child so she must have killed her. We punish mothers for not keeping their children safe by convicting of murder. LEGAL ADVOCACY FUND

The following paragraphs about the Supreme Court are from AAUW Washington Update.

"The Supreme Court handed down its first 4-4 decision since the passing of Justice Antonin Scalia. With only eight justices currently serving on the Court, the deadlocked decision may be a preview of future rulings. Hawkins v. Community Bank of Raymore raised the issue of whether the Equal Credit Opportunity Act, which prohibits bias on the basis of sex (and marital status), applies to both the borrower and the spouses who are required to guarantee their husbands' business loans. Lower courts agreed with the banks that the law only applied to the borrowers, not the spouses who were required to guarantee to secure the debt. The onesentence opinion upholds the lower court decision but does not set a national precedent and does not identify how each justice vote".

Senate Republicans Beginning to Budge on Supreme Court Confirmation Hearings

Two Republican senators stated that they do not agree with their party's decision to block confirmation hearings for Supreme Court nominee Merrick Garland. Sen. Susan Collins (R-ME) claimed it was "not fair" to block consideration of the nominee. She clarified that she has not yet reached a position on how she would vote during the hearings, but reiterated that the vetting process should move forward. Sen. Jerry Moran (R-KS) stated at a town hall that he believes it is his job to hold hearings for Garland, even if he does not plan to vote for confirmation. A recent poll found that self-identified Republicans from the public do not support a refusal of confirmation hearings.

Our Branch President Sara Ramaker adds:

Justice Antonin Scalia's death has left the court divided. AAUW urges Congress to undertake its constitutional duties to fill the seat. AAUW states: "AAUW members and supporters nationwide have

urged the president to move forward with a nominee, thereby beginning the critical constitutional process to fill the seat. The president believes that Garland, a seasoned appeals court jurist, meets the criteria for this lifetime appointment because of his 'independent mind and unimpeachable credentials [and an] unquestionable mastery of the law.'...

To do anything less could undermine the proud tradition of our constitutional government transitioning peacefully and efficiently, especially election years...History tells us that there is more than enough time to select and confirm a qualified nominee. Every U.S. Supreme Court nominee since the 1980s has received a prompt hearing and vote within 100 days. The longest wait, Justice Clarence Thomas took only 99 days while Sandra Day O'Connor was confirmed in just 33 days. President Obama' two previous nominees received hearings and votes with in 88 days."

Here is one reason why we need nine on the bench.

Arguments for <u>Whole Woman's Health v.</u>
<u>Hellerstedt</u>, perhaps the most significant reproductive case in years, will be presented before the Supreme Court this month. This case challenges the Texas "Targeted Regulation of Abortion Providers (TRAP) law. If the court upholds this law, a majority of reproductive health clinics in Texas would be forced to close. These regulations require the centers to have such things as unusually large hallways, the same as hospitals have to accommodate hospital beds, though the clinics never need such beds. (It is significant that clinics providing plastic surgery have none of these requirements) They also require women to take certain pills in this hospital setting. Women who

have a two-day regimen have to pay for a hotel room to stay two days just to take a pill! The closures will not just affect abortions, but all women's health care. AAUW states: "TRAP laws have been on the rise across the country, and the court's decision in (this case) could affect access to reproductive health care in many states." Having a divide court means the lower court's case holds. The cost, time and emotional stress must be endured again in order to get Supreme Court review.
