LEGAL ADVOCACY FUND (LAF)

Thank you and congratulations to everyone who supported the Legal Advocacy Fund by purchasing tickets for the raffle at our December Luncheon. We raised \$215.

The AAUW Legal Advocacy Fund supports women facing gender equity issues in the workplace. Our donations to LAF help AAUW fund cases that have the potential to change the legal landscape for women and girls.

LAF plaintiff Nathalie Gosset talks about her experiences in a new book by Gretchen Carlson [Be Fierce: Stop Harassment and Take Your Power Back](#). Her complete story and those of many others are included in this fascinating book.

LAF adopted Gosset's case in September 2016 when Gosset reported her sexual harassment experiences and was terminated from her job in retaliation, which is a direct violation of Title IX. The Gosset case which is now in the arbitration phase, was adopted by the AAUW LAF Committee because sexual harassment is a core issue that AAUW fights to put an end to.

The AAUW LAF Fund has been supporting gender discrimination cases for the past 35 years. The case support program provides financial and organizational backing for plaintiffs who are challenging gender discrimination in education and the workplace. The funds come directly from the contributions of AAUW members.

NCCWSL CONFERENCE SCHOLARSHIP OPPORTUNITY

For many years, AAUW has sponsored the National Conference for College Women Student Leaders (NCCWSL or "nick whistle"), which is an exciting opportunity for young women to receive leadership training. (The young attendees who spoke at the AAUW State Convention in Madison gave it rave reviews.) This year it will be at the University of Maryland, College Park in June.

AAUW Wisconsin is sponsoring two \$500 scholarships to two young Wisconsin student leaders so they can attend the conference. Eligible nominees must be currently enrolled in a program leading to an Associate degree (or equivalent), Bachelor's degree, or master's degree at a technical college or other two or four year public or private college. Candidates must be nominated by an AAUW branch with a limit of one nominee per branch. Branches are encouraged to provide additional support for the nominee for airfare and other expenses beyond registration. (It is estimated an additional \$500.) Registrations must be submitted by February 1.

It would be wonderful if our branch would nominate someone. I would like some help in trying to advertise this opportunity. It would be great to have two members help me brainstorm on the best way to handle this. Please contact me if you have a few hours.

Update on the Wetlands Bill for Social Justice Group

I have received a response from Senator Cowles' office regarding our letters raising our concerns and objections to the new law that would remove regulations from nonfederal wetlands. For your information I have copied the letter below:

Hello Sara,

About a month and a half ago, you contacted Senator Cowles office to express opposition to Assembly Bill 547 regarding eliminating permitting for nonfederal wetlands. At that time when I spoke with you, you had inquired about whether there was a Senate version of that bill, and I indicated that it had not yet been introduced. As you asked for me to contact you once the Senate Bill was introduced, I am now writing you to notify you that the SB was introduced yesterday, 11/30. If you wish, you can subscribe to updates on the bill via email on the link I have included below:

The bill has been referred to the Senate Committee on Natural Resources and Energy, which Senator Cowles Chairs. Given that the bill was just introduced, Senator Cowles is just beginning to thoroughly evaluate the bill.
