In Tokyo, 16-year-old Nao has decided there's only one escape from her aching loneliness and classmates' bullying. But before she ends it all, Nao plans to document the life of her greatgrandmother, a Buddhist nun



who has lived for more than a century. A diary is Nao's only solace, and will touch lives in ways she can scarcely imagine. Across the Pacific we meet Ruth, a novelist living on a remote island who discovers a collection of artifacts washed ashore in a Hello Kitty. As the mystery of the lunchbox's contents unfolds, Ruth is pulled into the past, Nao's drama and her unknown fate, and forward into her own future. opening book, same-sex marriage is hardly new. Revered by their community, Charity and Sylvia operated a tailor shop in the 19th century that employed many local women, served as guiding lights within their church, and helped to raise their many nieces and nephews. Charity and Sylvia is the intimate history of their extraordinary 44-year union. Drawing on an array of original documents including diaries, letters, and poetry, Cleves traces the couple's lives in sharp detail.



STEM IS WORKING!!

Everyone's efforts in providing more opportunities for girls to focus on technology is making an impact. The following article by Sally Ho was released by the Associated Press this week.

Girls outpace boys in tech, engineering

Although less likely to study in a formal technology or engineering course, America's girls are showing more mastery of those subjects than their boy classmates, according to national education data.

The findings from the National Assessment of Educational Progress also shows U.S. eighthgraders in 2018 did significantly better overall compared to 2014's test results, particularly among students who are white, black, Asian or lowincome.

The gap between girls and boys is also growing wider as compared to the last time the federal government compiled technology and engineering literacy data among a representative sample of students and public schools across the country.

In 2018, girls on average scored five points higher than boys on a 300-point scale because girls made gains between 2014 and 2018 while boys' scores stayed about the same.

The latest findings suggest the decade-long effort to champion more opportunities for girls and women in the fields of science, technology, engineering and math is gaining ground.

Her Story: History Comes Alive

Thursday, May 23 – Caroline Quarlls – The first women to travel through Wisconsin's Underground Railroad. Quarlls escaped from St. Louis and sought refuge and freedom in Milwaukee.

Other Women in History

March 13, 1986, <u>Susan Butcher</u> became the second woman to win the Iditarod Trail Sled Dog Race. Later she became the first competitor to win four out of five sequential years (1986, 1987, 1988, and 1990). In 1985, she was forced out of the race after her dogs were attacked by a moose. Unfortunately, she died at the age of fifty-one in 2006. On March 1, 2008, Governor Sarah Palin announced that the state of Alaska would recognize the first Saturday of every March as Susan Butcher Day.

Wisconsin was the first State to ratify the 19th Amendment: Jessie Jack Hooper from Oshkosh, Wisconsin, jumped on the first train for Washington, D.C. immediately after the Wisconsin legislature ratified the 19th Amendment. By delivering this information personally, Wisconsin became officially the first state to ratify the 19th Amendment.

GENDER BIAS IN HEALTHCARE

The latest Costco Connections magazine has an article about gender bias in healthcare (pgs. 90-91) and the following is taken from it. Man, age 40, feels chest pain and passes out. He is seen a cardiologist who does a full work up and found an electrical conduction problem with his heart. A woman, age 40, same symptoms is given EKG and an echocardiogram and is told it was a one-time episode. The woman's doctor sent her to a different cardiologist, had the proper workup and received same diagnosis as the man. Why the difference? There was a blatant example of discrimination and treatment differences between men and women. A recent study found: 1) women spend 65 minutes to men's 49 in emergency; 2) prescribed less pain medication; 3) more often diagnosed with a mental health vs physical one ("all in her head"); 4) Women less likely to survive a traumatic health episode than men and 5) Women less likely to receive same care after heart attach than men and experience an 11% higher death rate sue to that difference in post-heart attack care. Why? Women have different symptoms and communicate differently. Women search for medical information that can help and doctors see this as doctor shopping obsessive compulsive disorder. What to do? 1) Bring a one-page synopsis of what is going on. 2) bring an advocate to make sure all is heard and all questions are answered. 3) Present self well, learn a few medical terms and do not be easily dismissed. 4) Seek a second opinion and send an email to physician who has discounted you, saying, "I did have x-problem," to help education practitioners.
